Ontario Provincial Police Report for the Months of May and June 2025

Board Member Rob Pope request that the OPP reports be broken down for each Municipality and that the report be emailed at least one week prior to the NOPP Board meeting for Board Members to review.

Board Member Erik Kowal commented that as Board Members we are accountable to residents. Residents from each Municipality have to be informed of what is happening in their community.

Vice Chair Lou Rinaldi informed Board Members during negotiations with the Ministry on the amalgamation of Police Services Boards, the Ministry agreed that each Municipality would continue receiving individual reports for their Municipality.

Board Members agreed that this concern should be addressed to MPP David Piccini.

OPP Detachment Commander Mike Cavanagh reviewed the matters of interest for the Northumberland OPP Detachment Board Members for the months of May and June 2025.

Detachment Commander Mike Cavanaugh advised Board Members that OPP staff is down to 70% in Northumberland County. 5 new members and 3 experienced officers have been hired and will start September 15, 2025.

Chairperson John Davison informed Board Members of emails received regarding complaints from residents.

1. Complaint from residents regarding ATVs in the area McBride Road and Burnham Street.

Detachment Commander Mike Cavanagh replied that each Municipality has their own bylaws regarding ATVs. OPP will increase patrols in this area

2. Ongoing Noise Complaints in Bewdley

Detachment Commander Mike Cavanagh advised Board Members that the bylaw officer was sent to the address. OPP are still investigating.

3. EDR Not Being Respected. Motorists Using Roads Not Constructed for EDR When 401 Shut Down or Slow.

Detachment Commander Mike Cavanagh informed Board Members that the OPP will sit down with Public Works from each Municipality to come up with a plan to deal with this issue

4. Safety Concerns for First Responders On 401

Detachment Commander Mike Cavanagh suggested that MTO crash trucks could be used to block firetrucks from traffic while responding to incidents on the 401. The response time from the MTO is usually very good.

1. OAPSB Spring Conference

The Board Members agreed the conference was geared more towards larger Police Boards and not OPP Detachment Boards.

The OAPSB advised attendees that the Ministry will be developing standard policies and bylaws for Boards. Many Boards have decided to continue with their own policies and bylaws.

The OAPSB advised OPP Detachment Boards to develop their own policies and procedures when selecting a new Detachment Commander. Many Boards have not developed their own website and are still using their Municipal website for their Board information. Many Boards are interested in finding a company that would develop all OPP Board websites to help with cost.

2. Speed Limit Reduction Edville – Sandra Arthur

Residents in the area of Edville have requested a reduction in the speed limit. Detachment Commander Mike Cavanagh advised that the Black Cat report did not support the request for speed reduction. Board Member Sandra Arthur commented that an incident on the 401 in May, the Black Cat reported 2600 vehicles in the area.
