Ontario Provincial Police Report for the Month of February 2025

Northumberland OPP Staff Sergeant Ashley Gillard reviewed the matters of interest for the Northumberland OPP Detachment Board Members for the month of February 2025.

Staff Sergeant Ashley Gillard advised Board Members that she will be resigning her position with the OPP for the position of Inspector for Port Hope Police Services. Staff Sergeant Mike Davidson will be returning April 13.

Board Member Brian Ostrander requested more school patrols in Brighton. With the nicer weather returning, and more students out, there is typically an increase in incidences. Staff Sergeant Ashley Gillard will bring this request to Detachment Commander Kristy McNaughton.

Board Member Erik Kowal suggested that Officers on foot patrols around Campbellford should stop into businesses in the area for a greater police presence to deter shop lifting. Acting Staff Sergeant Shawn Herrell advised Board Members that foot patrol data will be entered on a spread sheet for information. Officers on foot patrol will be advised to visit downtown businesses.

Chair John Davison advised that there has been a complaint by a resident on Meyer's Road in Hamilton Township regarding speeding. Hamilton Township Roads Department will set up the Black cat in the area. More OPP patrols in the area have been requested. Staff Sergeant Ashley Gillard will have the Traffic Sergeant discuss concerns with this resident.

Staff Sergeant Ashley Gillard also reviewed the traffic report.

*Snowmobile patrols were conducted in the Rice Lake/Bewdley area (Hamilton Township) Ganaraska Forest (Hope), Alnwick/Haldimand, Warkworth and Campbellford areas. *

Several snowstorms over the month which kept our traffic units busy with collisions and assisting motorists who became stuck in the ditch or snow drifts.

Hamilton Township

Traffic patrols/Enforcement continue County Roads 2, 9, 15, 18 and 45. We continue with patrols and enforcement on Danforth Road, just east of Jarvis Road and Ontario Street (**Confirmed through speed enforcement**). County Road 18 from the 401 out to Gores Landing, targeting the speed reduction zones in the hamlets of Camborne, Cold Springs, Plainville, and Gores Landing. (**Regular speed enforcement will continue at those locations.**)

Alnwick/Haldimand

Traffic Patrols / Enforcement continue County Roads 2, 9, 22, 23 and 29. Concentrating on County Road 22 through Centreton (complaints of vehicles speeding) (**confirmed through speed enforcement**) We continue to conduct enforcement on County Road 2 into the Village of Grafton, several tickets being issued for speeding at this location. MacDonald Road for speeders, several patrols but no speeding issues yet. Will continue patrols.

Cramahe Township:

County Roads of 2, 25, 27, 31.

We continue patrols of the intersection of 25 and 27, Morganston (complaints of speeding and failing to stop at stop sign)
Enforcement on Purdy Road has been productive.

Municipality of Brighton:

County Roads of 2, 26, 27, 30 and 41.

Continuing to focus on County Road 2 between Boes Road and John Street. (Speeding complaints). **(high volume of traffic with several speeding infractions)**

Old Wooler Road **(Good location for continuous enforcement)**

Municipality of Trent Hills:

County Roads 8, 25, 30, 35, 38, 50

Front Street North just outside of Campbellford (speeding) **(Good volume of traffic and speeds at this location) We are continuing enforcement at this location.**

11th Line East and Godolphin Road for speeding. **(These locations are hit and miss but the Black Cat Reports are assisting officers)**

We have conducted enforcement on County Road 50 in response to a few complaints, but the officers have not received the speeds in which the complaints have stated. Patrols will continue.

Alderville First Nation

Early morning and evening patrols have of County Road 45, through the community. Several offence notices being issued during these patrols.
